- (4) That the proposals submitted by the Leaders of the Conservative, Liberal Democrat and Informal Independent Groups as shown in the schedule which will be circulated at the Council meeting, be approved.
- (5) That two Parish Council representatives (as set out below and on the schedule to be circulated at the Council meeting), be appointed as non-voting members of the Standards Committee.
- (6) That the principles of proportionality be applied to Committees at such time as they might appoint time limited Sub-Committees and Joint Committees.
