Notice Is Hereby Given that the District Council has received applications for planning permission, Listed Building Consent, a Departure, Major Development, Significant Development, or which may affect a Public Right of Way, as the case may be, for developments as briefly described in the following schedule.

**MO/2018/0363/PLAH: Woodlands Farm, Reigate Road, Hookwood, RH6 0HH:** Erection of detached store and garage following partial demolition of existing outbuilding.

**MO/2018/0383/PLAH & MO/2018/0384/LBC: Woodlands Farm, Reigate Road, Hookwood, RH6 0HH:** Erection of single storey rear extension. **MO/2018/0391/PLAH: Draycote, Guildford Road, Westcott, RH4 3NW:** Subdivide existing detached dwelling into 1 No. pair of semi-detached dwellings. Erection of single storey side extension and changes to fenestration to include 2 No. dormer windows to west roof elevation.

**MO/2018/0514/ADV: 207-213, Blenheim House, High Street, Dorking, RH4 1RU:** Retrospective application for erection of 1 No. non-illuminated hoarding sign with a width of 2.0 metres and overall height of 4.0 metres from ground level. **MO/2018/0575/PLAH: 8, North Street, Dorking, RH4 1DN:** Erect two storey extension following removal of existing single storey element, render and clad existing brickwork. (Amendments to approved scheme approved under MO/2017/1331, including insertion of rooflights and other changes to fenestration). **MO/2018/0597/PLA: Ridgelea and Briar Bank, Guildford Road, Fetcham:** Erection of 8 No. dwellings and associated access and landscaping, following demolition of existing dwellings. **MO/2018/0598/PLA: 45-47, Church Street, Leatherhead, KT22 8EP:** Various works to return existing single dwelling back to 2 No. separate dwellings: Demolish both rear symmetrical closet wings at first floor level and the infill extensions at ground level, and replace with a symmetrical two storey extension, also replace the existing single glazed windows on front, side and rear elevations. **MO/2018/0603/PLAH: April Cottage, 151, The Street, Capel, RH5 5EL:** Erection of single storey rear extension and loft conversion with one rear dormer window with Juliet balcony.
