MO/2020/0954: Oakstead, Mill Lane, Hookwood, RH6 0HX: Erection of a pair of semi-detached dwellings with associated parking and access. **MO/2020/0966: Rallywood, The Green, Ockley, RH5 5TR:** Conversion of garage to enlarge existing annexe ancillary to Rallywood (one 4-bed annexe). **MO/2020/0967: Rallywood, The Green, Ockley, RH5 5TR:** Conversion of garage, to enlarge existing annexe ancillary to Rallywood (one 4-bed annexe). Removal of internal walls, creation of two new window openings with the installation of new windows throughout the annexe. Alteration to internal floor plan and blocking up of external doors (application for Listed Building Consent). **MO/2020/1062 & MO/2020/1063: Northlands, Froggetts Lane, Wallis Wood, RH5 5RJ:** Convert existing conservatory into boot room with oak entrance porch. **MO/2020/1067: Bluebird House, Povey Cross Road, Hookwood, RH6 0AF:** Outline application for the consideration of access and scale in respect of the erection of 9 No. dwellings following demolition of existing commercial buildings. **MO/2020/1068: Sun Cottage, Rosemary Lane, Charlwood, RH6 0DG:** Block up rear external door to kitchen, remove paint from front elevation and enlarged window to rear elevation/study. **MO/2020/1069: Sun Cottage, Rosemary Lane, Charlwood, RH6 0DG:** Brick up rear door to kitchen, creation of new shower room at first floor, relocation of boiler and other internal works, enlarged window to rear elevation/study and removal of paint on front elevation. (Application for Listed Building Consent.) **MO/2020/1082: Danesmead, Ockley Road, Forest Green, RH5 5SG:** Erection of a detached double garage. **MO/2020/1098: 32B, Church Street, Dorking, RH4 1DW:** Erection of single storey rear extension with alterations to roof following demolition of existing conservatory. **MO/2020/1108: Boxhill Kennels and Cattery, Boxhill Road, Boxhill, KT20 7JF:** Demolition of disused kennel and cattery buildings with associated sheds and the provision of 2 No. residential dwellings with associated access road and outdoor space for each property. **MO/2020/1114: Hall Stables, Swanworth Lane, Mickleham, RH5 6DY:** Subdivision of an existing property into two separate dwellings, minor changes to fenestration in existing elevations and to roof-lights. **MO/2020/1146: 33, Dene Street Gardens, Dorking, RH4 2DN:** Replacement front door (Article 4 Direction application).
